### **General Business License Information**

<u>General Requirement</u>: Any activity engaged in that provides goods or services to the public within the unincorporated area of the County of Imperial.

Pursuant to statute, "No person, whether individually or as an agent of another, shall engage in any business enterprise in the unincorporated portion of the County of Imperial without having first obtained a license therefore from the County Treasurer-Tax Collector".

However, as of December 2, 2014 a resolution was passed by the Board of Supervisors that provides for exemptions for certain types of businesses. That resolution exempts businesses engaged in "Agricultural Operations", landlords who lease their land to others and do not conduct any other business, and some businesses that also operate in one of the incorporated cities within Imperial County <u>and</u> have a current business license from that city. <u>Special Note:</u> In the case of temporary or mobile vendors, a business license from another city <u>does not</u> exempt them from this process and an Imperial County General Business License is required. Proof of any of these exemptions shall be required. If you have questions as to whether your particular business qualifies for any exemptions, please contact the Treasurer-Tax Collector's office at the number shown below.

- Due to Federal laws or statutes, the following exemptions also apply:
  - 1) Businesses that are doing **internet only sales** do not have to have a county business license.
  - 2) Businesses that are only selling products or providing a service to casinos or other **tribal businesses located on tribal land** do not have to have a county business license.
  - 3) Businesses that are <u>operating on tribal land that is leased from a tribe</u> in the unincorporated areas of the county do not have to have a county business license.

#### LICENSE FEES: For one month, or less:

- -\$50.00 license fee
- -\$25.00 county processing fee
- -\$72.00 Basic Fire Inspection Fee (where applicable)
- \$ 1.00 statutory State Disability Access and Education Fund fee (in effect until Dec. 31, 2018 under CA AB-897)

### For more than one month and up to one full year:

- -\$250.00 license fee
- \$ 25.00 county processing fee
- \$ 72.00 Basic Fire Inspection Fee (where applicable)
- \$ 1.00 statutory State Disability Access and Education Fund fee (in effect until Dec. 31, 2018 under CA AB-897)

Non-Profit Organizations: Exempt from License Fee, but required to pay \$25.00 application fee and the state mandated \$1.00 fee, for a total of \$26.00. Applicant must attach valid proof of non-profit status.

<u>Veterans</u>: Fee exemption provided for Veterans as long as the business is owned by the applicant. Must have received an honorable discharge or a release from active duty under honorable conditions. Copy of DD2-14 required. If application shows a business name that is fictitious, must also provide a copy of state resale license (sales tax) permit and a fictitious name statement proving that the veteran is the owner of

that particular business. Exemption applies to the basic fire inspection fee also. However, the state mandated \$1.00 fee must accompany all veteran applications.

In addition to the fees shown above the applicant may be required to pay other applicable fees to the County of Imperial and its departments for inspections, background investigations, services, or such other fees as may normally be required by the department; including but not limited to the fire department, sheriff's office, planning and building department, agricultural commissioner, health department, air pollution control district, or any other agencies of the county.
